

Weinert Elementary Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

Weinert Elementary agrees to implement the following statutory requirements:

4. 5. 6. Weinert Elementary will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

7. Weinert Elementary will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

- *Sending home a letter from the principal with an explanation of how their students will be supported academically during the absence of a highly qualified teacher.*

8. Weinert Elementary will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --

- the state's academic content standards,
- the state's student academic achievement standards,
- the state and local academic assessments including alternate assessments,
- the requirements of Part A,
- how to monitor their child's progress, and
- how to work with educators:

9. Weinert Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
